


In which countries are the most Treasury securities held?

Notes: Countries highlighted on the map hold at least \$1 billion in Treasury securities and together represent more than 99 percent of all foreign holdings. Data on Treasury securities held by Serbia and Montenegro are reported together, totaling about \$1.7 billion as of June 28, 2019 (map). The map does not include data for Treasury securities held by international and regional organizations, unknown countries, and countries for which Treasury did not report data.

Greater than zero but less than \$500,000: Ethiopia, Faroe Islands, Saint Martin & Saint Barthelemy, Senegal, Sudan, Yemen, Zimbabwe.
